The meeting was called to order by Louis Paciello at 5:08

I. Approval of Minutes from September 13, 2023

Louis Paciello made a motion to approve the Minutes from June 7, 2023, and Kelly Scott seconded.

III. Finance Report

A. Expenditure Report and Fund Balance - the committee reviewed the reports that were provided and will ask questions if needed at another meeting

A. General Update - AISC is Nov 2, the MVRHS Committee mtg is Nov 7

B. Special Education Update - Hope MacLeod distributed handouts regarding participation in the shared services programs; the responses to a recent parent survey; and state data in regards to participation rates.

C. ELL Report Leah Palmer - presented information about the programs she directs.

She is also sharing a video about the benefits of being multilingual with Dr. Einbinder who can share it with the school committee. Edgartown scored the highest of all island schools on the English Language Proficiency Progress scores on the MCAS report a 4 out of 4.

D. Superintendent's Evaluation -Dr. Smith summarized the process for accelerating the review and rating process.

Kelly Scott made a motion to submit the review and Laura Seguin seconded. There was no discussion, comments or changes. The motion passed: 3 Ayes, 0 Nays

V. Principal's Report

A. MCAS Data - Dr. Einbinder presented information on what the faculty is doing to address the MCAS scores. She thanked Mary Ellen Guyther, 5-8 Math specialist, and Melanie Brown 6-8 Literacy specialist, for all the work they have done leading the staff in examining the test results.

B. 8th Grade Trip – Discussion of Location and Possible Vote MaryEllen Guyther and Gina Debettencourt presented information about the 8th grade trip and the recommendation for a New York City and Philadelphia trip.

Kelly Scott made a motion to approve the plan for the 8th grade trip to go to New York and Philadelphia for the foreseeable future and Laura Seguin seconded.

Louis Paciello made a motion to approve the short term Leave of Absence for Marcia Borges from October 2 until the ELL teacher Nicole Miranda returns and Kelly Scott seconded.

3. Retirements - Jennifer Fournier, current grade 1 teacher, and Michelle Pikor, current Physical Education teacher, will retire at the end of the school year.

4. Request for Approval of School Choice Funds for Nursing Services and Special Education Invoices

\$2,660.97 was requested to pay for nursing services that were provided last year on the ski trip.

\$1,266.92 for special education services provided last year but the invoices were not received until this fiscal year.

Louis Paciello made a motion to approve the use of school choice funds for these expenses and Kelly Scott seconded.
