I. Middle School Re-entry Plan

The Edgartown Middle School Re-entry Plan was first presented and approved by The Health and Safety Committee at a meeting on October 29, 2020, Dr. Einbinder explained. The plan will phase-in two grades at a time.

On Tuesday, November 10, students in grades 5 & 6 will return to in-person learning 4 days per week, Tuesdays-Fridays, from 8:20am-2:40pm. Mondays will be a fully remote day for all grade 5 & 6 students. There are currently 36 students in Grade 5, with 8 students who are fully remote, and 56 students in Grade 6, with 10 students who are fully remote. These two grades will use the main entrance of the school and proceed left to their classrooms located on the first floor.

On Tuesday, November 17, students in grades 7 & 8 will also return to in-person learning 4 days per week, Tuesdays-Fridays, from 8:20am-2:40pm. Mondays will a fully remote day for all grade 7 & 8 students. There are currently 37 students in Grade 7, with 9 students who are fully remote, and 39 students in Grade 8, with 4 students who are fully remote. These two grades will use a completely separate entrance known as "the link" to enter the school. They will proceed to the enclosed staircase and make their way upstairs to their classrooms located on the second floor.

Each homeroom will have between 12-14 students, each with their assigned/named seat with 6 feet of social distancing. Even if all fully remote students were to return to in-person learning, they would still be able to accommodate and maintain the 6 feet of social distancing.

The students will remain in their homerooms to receive instruction, it will be the teachers who will rotate. Teachers will be encouraged to open windows whenever possible. Students will eat lunch at their assigned desks in either their homeroom or outdoors using the tents, weather permitting. There will be at least two mask breaks per day.

Nurse Barlett continues to provide ongoing health and safety training to each and every classroom. There will be strict adherence to the mitigation strategies and COVID 19 protocols as outlined by the Health & Safety document on the school website.

After a lengthy discussion and considerable input from the community, on a motion by Kelly McCracken, seconded by Kimberly Kirk, the committee unanimously approved the Edgartown Middle School Re-entry plan as presented by Dr. Einbinder by way of roll can vote.
