IV. Superintendent's Report

A. General Update

The Chilmark / West Tisbury School Up Island Regional Schools and Oak Bluff School voted on their budgets and the Tisbury School is scheduled to vote January 9. The Edgartown and MVRHS budgets are being voted on Jan 8.

B. Special Education Update – Hope MacLeod was absent so there was none.

V. Principal's Report

A. FY25 Budget Presentation - Dr. Shelley Einbinder presented a slideshow:

Shelley - do you want this included or just leave it as "presented a slideshow"

Enrollment: 375 students with 1 pending enrollment

Special Education Student percentage is now 22%

75 students are in the EL program currently - 19.8%

Just over 50% of families qualify for free or reduced lunch

The current NESDEC projection of student enrollment is now under 400 students for the next 10 years. This is a recent change from what was projected in the past and an addition in information to the slides presented

The average class size is 17

3 students are being homeschooled

17 students are in other schools through School Choice

2 students are in Edgartown through School Choice

34 students are in the Charter School

2 students are in the Falmouth Academy

7 students are in Vineyard Montessori

0 student are in residential schools

Version 3 of the budget was presented: Mark Friedman explained that the Version 3 of the Budget represents a 7.18% increase. A portion of that percentage was influenced by the increase in the shared services budget. The state of Massachusetts supplements some of the special education costs through funds from the Student Opportunity Act. These are relatively new funds and will increase over the next 3-5 years.

Kelly Scott made a motion to approve the budget.

Louis Paciello seconded.
