The meeting was called to order at 5:36 p.m.

I. Approval of Minutes from February 28 and March 13 meetings.

Kelly Scott made a motion to approve the minutes and Mr. Paciello seconded. There were no discussions, comments or changes. The motion passed: 2 Ayes, 0 Nays

II. PTA Report - there was none

III. Finance Report - Mark Friedman reported on the following:

A. Expenditure and Fund Balance Reports

B. Donations - Shelley Einbinder reported on an anonymous donation in the amount of \$11,025 to go towards the 7th grade ski trip for next year.

Kelly Scott made a motion to accept the \$11,025 donation to support the ski trip next year and Louis Paciello seconded with gratitude.

C. School Choice Fund Request Richie Smith asked that \$5,915 from the school choice funds be used to pay a \$5 differential to ESPs from the 2022-2023 school year.

Kelly Scott made a motion to approve the use of \$5,915 from School Choice to pay a \$5 differential and Louis Paciello seconded.

There were no discussions, comments or changes.

The motion passed: 2 Ayes, 0 Nays

V. Superintendent's Report

C. Richie Smith reported on the work done on the Student Opportunity Act. It is a 3-year plan that is reviewed each year. The school committee will get a report each year.

IV. Principal's Report -

A. Shelley Einbinder reported that she worked on two areas when she submitted the 3-year plan for the Student Opportunity Act:1. Supporting Curriculum implementation on early literacy and 2. Collaborative Teaching models. The total investment will total \$267,650.

Kelly Scott made a motion to accept the Student Opportunity Act and Louis Paciello seconded.

There were no discussion comments or changes.

The motion passed: 2 Ayes, 0 Nays

- B. Enrollment Shelley Einbinder reported that as of April 1 there were 376 students.
- C. Personnel Richie Smith reported on Shelley Einbinder's request to retire effective July 1.

Kelly Scott made a motion to accept Shelley Einbinder's retirement and Louis Paciello seconded with gratitude.

There were no discussions, comments or changes.

The motion passed: 2 Ayes, 0 Nays

VI. Public Comment

A question was asked about Dr. Smith's plan for replacing the administration at the Edgartown School and Dr. Smith said he would announce the plan later in the spring.

VII. New/Old Business

Hope McLeod reported that there is still potential for a student to be going to residential but that is in progress and no decisions have been made.
