D. Grievance Discussion-Use of School Choice Funds and Vote

Essentially a breach of contract-when administration doesn't follow, the union will bring grievance. Grievance goes to principal, Superintendent, and then School Committee.

In the fall, a teacher here was not credited for time he worked part time, therefore not credited longevity. They were correct, and I asked them to file the grievance.

Essentially in the last round of negotiations we were bargaining with the teacher unit, and did not ratify contract until November 2022.

New contract had wording that in old contract said you needed to be at top step. New contract that language was missing.

Longevity pay \$3500 dollars should have been paid to this employee.

Asking to use school choice money.

Legitimate grievance. We owe this employee \$3500.

Motion to use school choice in the amount of \$3500

V. Finance Report

A. Expenditure and Fund Balance Reports-Mark Friedman

Standard fund balance and expenditure report

Three different funds in this report

We still have 1.4 million dollars available for the larger phase of the playground construction.

PTA has generously gotten us some outside donations

School choice fund 401-\$233,000 balance

Healthy balance/additional 11, 000 expected

Revolving lunch fund balance currently at \$141,000 very healthy balance. With Gina's help we will spend some of that down.

Expense Report: lots of variances

Focusing on salaries alone- all together when you add together projected surpluses and deficits we still have \$37,000 projected savings.

Will caution one of the lines we do not encumber monies is on page 2 salary surplus will be eaten up by subs

Variences -staff last year moved into different positions. Reflective of people newly hired or moved after budget finalized.

Towards end of report custodial overages -unanticipated position- covered in what I just mentioned

Page 5 -activity and maintenance area-deficit. Will look to cover that at the end of the year.

Overall the budget is in good shape.

Page 5 very bottom residential another residential line on page 3

Page three \$199,000 spent- unbudgeted. Reminder that the strategy is we are applying to the state for circuit breaker for extraordinary relief. Application in- We won't hear for a while.

Our expectation is that the state will come back with significant relief for us. Will not cover 100%

April 8 is also special town meeting

School has request for stabilization fund as well as \$120,000 to be deposited into that fund.

Should any of the budget assumptions end up short, we have the school choice fund to address any variances

Won't hear from state until April or May

Brown has question Page 5 playground equipment \$2000 that hasn't been spent. Not donation. That represents maintenance that happens every year. We have delayed as best we can but kept equipment safe.
